In support of this application True Natural Gas respectfully shows the following:

1.

True Natural Gas is a natural gas marketing company that has been certified by the Commission to market natural gas to end-users in all delivery groups and pools in the State of Georgia.

As an active natural gas marketer, True Natural Gas has both a legal and a property interest in this proceeding. It receives distribution service from Atlanta Gas Light Company for all of its customers, and is allocated or assigned a proportion of Atlanta Gas Light Company's costs for various services and programs. True Natural Gas is also a competitor of SouthStar Energy Services LLC, d/b/a Georgia Natural Gas.

In a competitive marketplace, no other party, including other gas marketers who have or may apply for intervention in the above-referenced docket, can adequately represent True Natural Gas' rights and interests in this matter.

True Natural Gas' participation in this docket will not unduly delay or prejudice the rights of other parties. This application is timely filed pursuant to the Procedural and Scheduling Order.

True Natural Gas does not currently anticipate filing testimony, but it will notify the Commission and other parties of record if it files testimony pursuant to the December 15, 2015, Procedural and Scheduling Order.

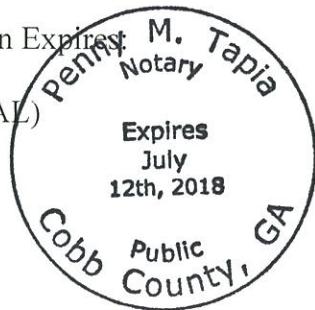
