RE: Name and Contact Change Notification

Dear Secretary McAlister:

Network Billing Systems, L.L.C. (“NBS”) hereby notifies the Georgia Public Service Commission (“Commission”) that the Company is changing its name from Network Billing Systems, L.L.C. to **Fusion Connect LLC**, effective June 1, 2019.<sup>1</sup> A copy of Fusion Connect LLC’s Secretary of State name registration is attached.

NBS maintains Certificates of Authority to provide competitive local exchange telecommunications services<sup>2</sup> and interexchange telecommunications services<sup>3</sup> as a non-facilities-based reseller of telecommunications services within the State of Georgia. The Company provides telecommunications services exclusively to commercial subscribers in Georgia and elsewhere. This change in corporate name will have no effect on the services offered to subscribers. The Company respectfully requests that the Commission amend the Company’s Certificate of Authority and Commission records to reflect the Fusion Connect LLC name, as appropriate.

On February 16, 2019 NBS notified the Commission of the Company’s election to de-tariff its Georgia retail telecommunications services effective immediately, pursuant to the Commission’s 2010 *Order* Implementing House Bill 168 in Docket No. 32235.<sup>4</sup> The Company has amended its
