(Reorganization)

Dear Mr. McAlister:

Fusion Cloud Services LLC (“Fusion Cloud”), Fusion Communications Services, LLC (“Fusion Communications”) and Network Billing Systems, LLC (“NBS”) ¹ (together, the “Fusion GA Companies”) respectfully submit this letter to notify the Georgia Public Service Commission (the “Commission”) that on June 3, 2019, their parent company, Fusion Connect, Inc. and all of its U.S. subsidiaries, including the Fusion GA Companies (collectively, “Fusion”), filed for protection under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Southern District of New York (the “Petition”).²

Fusion filed for Chapter 11 protection in order to restructure its capital structure. Following completion of the proposed restructuring, Fusion expects to emerge financially

stronger. Importantly, the filing of the Petition does not reflect, or result in, any immediate changes to Fusion's current operations. The Fusion GA Companies continue to serve their customers on an uninterrupted basis and the Chapter 11 filing does not in any way alter the rates, terms and conditions under which they provide those services to their customers. Thus, the bankruptcy filing itself will be transparent to the customers of the Fusion GA Companies, as they will not experience any difference in how their service is provided or in the caliber of customer service available to them.


