5. WHEREAS all parties to this action, Georgia Power Company ("Georgia Power") and Walton Electric Membership Corporation ("Walton EMC"), consent to permit Nestle Purina's intervention in the action.

THEREFORE, it is ORDERED that Nestle Purina PetCare Company is permitted to intervene in this action and shall have all the rights and liabilities of a party to this action. It is further ORDERED that Nestle Purina PetCare Company shall submit an Answer to Georgia Power's Petition by July 29, 2019.
