NOTICE OF INTENT TO FILE COMMENTS

Georgia Electric Membership Corporation ("GEMC") hereby files its Notice of Intent to File Comments in the above-docketed matter:

1.

GEMC is a trade association. Its members include the 41 electric membership corporations ("EMCs") in the state that provide electric distribution services, as well as Georgia Transmission Corporation, Georgia Systems Operations Corporation, and Oglethorpe Power Corporation, which provide transmission services, and operating and generating services to 39 of the 41 EMCs in the State. The remaining three EMCs receive transmission, and operating and generating services from the Tennessee Valley Authority.

The Notice of Inquiry in this docket seeks comments relating to how the Georgia Public Service Commission (the "Commission") should meet its responsibilities under Senate Bill 2 with regard to EMCs that have a broadband affiliate that provides retail broadband services. The outcome of this Docket will, therefore, have a direct effect upon EMCs with broadband affiliates, and even upon EMCs merely considering whether to offer broadband services.

GEMC files this Notice to indicate its intent to file comments on behalf of such of its members as choose to utilize GEMC for this purpose.




