## EXHIBIT A TO GEORGIA POWER COMPANY SUBPOENA

### Definitions and Instructions

As used herein, the term “You” (including any derivatives thereof) means Georgia Power Company, as well as any of its agents, officers, representatives, departments, divisions, or affiliated organizations.

The term “Electrify America” refers to Electrify America, LLC.

The term “Premises” refers to the electric vehicle charging facilities, including dispensers and power cabinets, installed at Johns Creek Town Center Shopping Mall, 3630 Peachtree Parkway, Suwanee, Georgia 30024.

The term “concerning” means, without limitation, relating to, regarding, referring to, reflecting, consisting of, evidencing, or constituting.

When a document is requested herein, the request includes any writings, emails, photographs, and any document maintained in a graphic, electronic, or other medium of any kind or nature.

### Requests

1. All documents concerning Electrify America’s solicitation of bids to serve the Premises and Your response thereto.
2. All documents concerning any analysis, assessment, evaluation, study, or consideration of whether the Premises would or does constitute a 900 kw customer choice load under the Georgia Territorial Electric Service Act.
3. All communications with Electrify America concerning the Premises.
4. All documents concerning Your design plans for extending electric service to the Premises.
5. All documents concerning Your extension of electric service to the Premises.
6. All documents concerning invoices or bills sent by You to Electrify America related to the Premises or electric service rendered thereto.
