Interstate Gas Supply, Inc. ("IGS") hereby files its Application for Leave to Intervene in the above-captioned proceeding in accordance with O.C.G.A. § 50-13-14 and § 46-2-59, Georgia Public Service Commission ("Commission") Rule 515-2-1-.06 and the Procedural and Scheduling and Order for Docket Number 44280. In support of this Application, IGS Energy respectfully shows the following.

1.

On April 7, 2022, the Commission filed a Procedural and Scheduling Order for Docket Number 44280 involving Georgia Power Company's 2022 Rate Case. IGS Energy seeks leave to intervene and participate in this proceeding. This application is timely filed.

IGS Energy is an independent retail natural gas and electric supplier based in Dublin, Ohio that operates in over 20 states with over 1,500,000 customers nationwide. Regarding renewable energy, IGS Energy has solar projects in 19 states, and has developed over 112 megawatts of solar power across the country. In Georgia, IGS Energy is the parent company of SCANA Energy Marketing, LLC ("SCANA"). SCANA is a certificated natural gas marketer to provide natural gas to retails customers in the State of Georgia. IGS Energy also has several

solar projects in Georgia Power's Advanced Solar Initiative and Advanced Solar Initiative Prime programs.

The rights and interests of IGS Energy will be substantially affected by decisions made by the Commission in Docket Number 44280.

Although there may be other intervening party applicants in this proceeding, who may have similar interests, no other party in this proceeding can adequately represent IGS Energy's rights and interests in this matter. IGS Energy's participation in the proceeding will not unduly delay or prejudice the rights of other parties.

IGS Energy is currently evaluating the extent in which it will provide direct testimony in this matter. Pursuant to the Procedural and Scheduling Order in Docket Number 44280, IGS Energy will provide more information regarding its intentions to provide direct testimony once those decisions are made.
