This letter is submitted on behalf of BullsEye Telecom, Inc (“BullsEye” or “Company”) to notify the Commission that the Joint Petition Regarding Internal Reorganization and Transfer of Customers filed with the Commission on April 3, 2023 (“Transaction”), Docket Nos. 33697 and 15693, has been completed and the customers of BullsEye were transferred to its affiliate Lingo Telecom, LLC (“Lingo”) effective July 1, 2023. BullsEye states that all of its customers are now being served by Lingo, it has ceased operations in the state of Georgia, and hereby requests cancellation of its Georgia Certificates of Authority, R-0854, A-0214 and L-0304, and any tariffs on file with the Commission effective as soon as possible.
