
**PROPERTY OWNER RESPONDENTS' REQUEST FOR
ISSUANCE OF SUBPOENAS FOR DEPOSITIONS OF PETITIONER'S WITNESSES**

Pursuant to the Notice of Hearing and Scheduling Order in this matter and O.C.G.A. § 50-13-13(a)(6), Property Owner Respondents hereby request that the Hearing Officer issue subpoenas requiring Petitioner Sandersville Railroad Company to produce for deposition the following seven witnesses who submitted pre-filed direct testimony in this matter: Allen R. Haywood; Benjamin J. Tarbutton, III; Cale Veal; Scott Dickson; Jeff Custer; Gregory D. Teague; and Arnie Pittman. Additionally, Property Owner Respondents request that the Hearing Officer issue a subpoena requiring Petitioner Sandersville Railroad Company to produce a representative for deposition of an organization pursuant to O.C.G.A. § 9-11-30(b)(6).

The depositions will be conducted by counsel for the Property Owner Respondents at dates and times mutually agreed upon by counsel for the parties, but not after November 15, 2023. The depositions will be conducted according to the Georgia Rules of Civil Procedure.

Property Owner Respondents plan to request subpoenas for depositions of any other witnesses, as yet unknown, who submit pre-filed testimony in this matter. Property Owner Respondents also plan to cross-examine all witnesses, currently known and unknown, who submit pre-filed testimony in this matter at the hearing currently scheduled for November 27-28, 2023.


