**AT&T GEORGIA’S REPLY BRIEF SUPPORTING EXCLUSION OF
AFFILIATE TRANSACTION REVENUES FROM REVENUES THAT ARE
SUBJECT TO CONTRIBUTIONS TO THE UNIVERSAL ACCESS FUND**

In compliance with the Procedural and Scheduling Order on Universal Access Fund Contribution Methodology entered in this docket on August 1, 2023 (“PSO”), AT&T Georgia¹ respectfully submits this Reply Brief supporting its position, set forth in its initial Brief, that that Georgia law permits it to exclude revenues from affiliate transactions from its revenues that are subject to the Universal Access Fund (“UAF”) contribution factor.

Other than AT&T Georgia, only two entities (GTBA and RTS) submitted Initial Briefs (or, in the case of RTS, an initial letter) in this proceeding, and neither of those submissions suggest that Georgia statutes or Commission Rules prohibit AT&T Georgia from excluding revenues from affiliate transactions from its revenues that are subject to the Universal Access Fund (“UAF”) contribution factor.

Accordingly, AT&T Georgia respectfully requests that the Commission enter an Order determining that AT&T Georgia is permitted to exclude revenues from affiliate transactions from its revenues that are subject to the UAF contribution factor.
