Dear Mr. Chairman and Commissioners,

The Georgia Public Service Commission (“Commission”) entered an Order in Docket Nos. 41559 and 43510 on December 13, 2022 approving the Chatham County Project and the Alamo Segment 3 Project proposed in Atlanta Gas Light Company’s 2023 Universal Service Fund Facilities Expansion Plan (the “2023 Plan”). On May 16, 2023, Atlanta Gas Light Company (“AGL” or the “Company”) filed a Petition with the Commission, requesting to amend the Chatham County Project. AGL then filed a letter with the Commission on May 26, 2023, requesting that the amendment be held pending additional information from the customers.

The Company previously stated that it would file an update to the 2023 Plan on October 1, 2023. AGL files this letter as notice that the Company will file a request to amend the 2023 Plan in the coming weeks to propose a new project in place of the Chatham County Project.
