**APPLICATION OF AT&T ENTERPRISES, INC.
FOR APPROVAL THAT MARCH 5, 2024, COMMISSION LETTER ORDER
DOCKET NUMBERS 36074 AND 36086 BE DEEMED APPLICABLE
TO AT&T ENTERPRISES, LLC**

On February 12, 2024, AT&T Communications of the South, and AT&T Corp. (collectively, the “Applicants”), filed an application with the Georgia Public Service Commission (“Commission”) requesting approval to participate in the merger of AT&T Corp. into a newly formed company called AT&T Enterprises, Inc.

As was more fully described in the application, AT&T Enterprises, Inc. (a wholly-owned subsidiary of BellSouth Mobile Data, Inc., which is a wholly-owned subsidiary of AT&T Inc., the parent corporation of AT&T Corp.) was the surviving entity and replaced AT&T Corp. as the provider of the services previously provided by AT&T Corp. in Georgia.

In Letter Order Docket, Docket Numbers 36074 and 36086, dated March 5, 2024, the Commission approved the merger of AT&T Corp. into AT&T Enterprises, Inc.

As a last step in corporate governance, consistent with efforts to rationalize corporate structure AT&T Enterprises, Inc. changed its name from AT&T Enterprises, Inc. to

AT&T Enterprises, LLC, and received an Amended Certificate of Authority, Name Change, from the Georgia Secretary of State on June 11, 2024. Exhibit 1 is the Amended Certificate of Authority, Name Change, from the Georgia Secretary of State.

Given that the underlying merger transaction has been approved and this application is solely a request to deem that approval applicable to the same business entity under a name change from AT&T Enterprises, Inc. to AT&T Enterprises, LLC, and no other changes relative to the initial merger application are being made, AT&T Enterprises, Inc. respectfully request that the Commission approve this Application and order that the March 5, 2024 Letter Order, Docket Numbers 36074 and 36086 be deemed fully applicable to the renamed entity: AT&T Enterprises, LLC.
