COMES NOW SCANA Energy Marketing, LLC (“SCANA Energy”) and files certain information as required by the Georgia Public Service Commission (“Commission”) pursuant to Commission Utility Rule 515-7-3-.04 (14).

Pursuant to the Commission Utility Rules, each certified natural gas marketer is required to file by the 5<sup>th</sup> day of each month its “standard fixed offer for residential customers and standard variable offer for residential customers”. Further, such filings shall include “the cost per therm for the commodity and upstream capacity charges, and shall also include the EDC’s base charge, the marketer customer service charge, and any other charges to be included in the offers.” In compliance with Commission Rules, SCANA Energy as the designated Regulated Provider herewith files its standard variable and fixed rates for Group 1 and Group 2 residential customers. Provided herewith on Attachment “A” are SCANA Energy’s rates for Group 1 and Group 2 residential customers.

Additionally, as requested by the Commission, SCANA Energy includes as Attachment “B” component parts of the commodity charges for both Group 1 and Group 2 customers.
