Q: Please state your name and business address.

A: My name is Stephen Mullen, and my business address is 1181 Cassville White Road, Cartersville, GA 30184.

Q: Mr. Mullen, by whom are you employed and what is your job position?

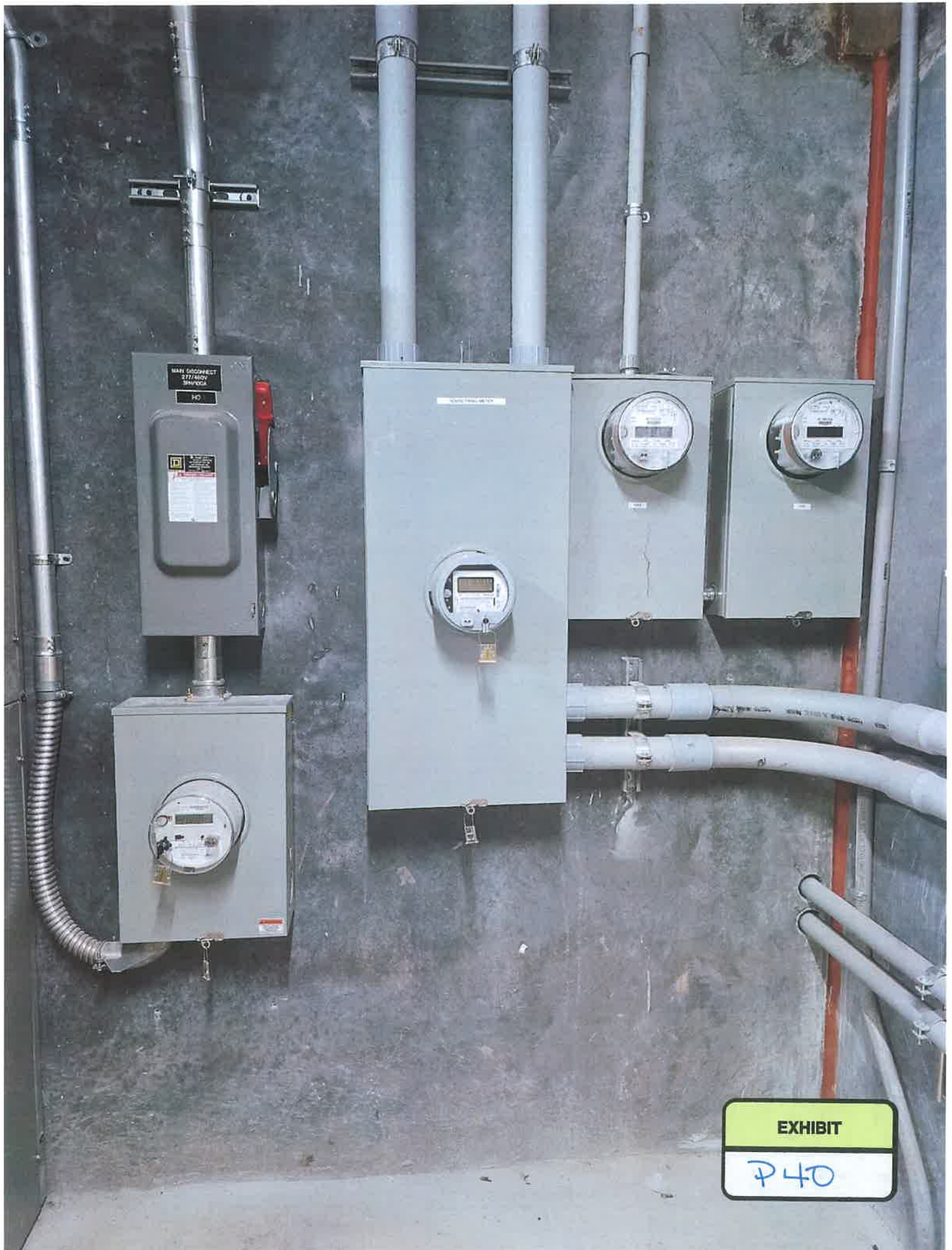
