Pursuant to the Commission Utility Rules, each certified natural gas marketer is required to file by the 5<sup>th</sup> day of each month its “standard fixed offer for residential customers and standard variable offer for residential customers”. Further, such filings shall include “the cost per therm for the commodity and upstream capacity charges, and shall also include the EDC’s base charge, the marketer customer service charge, and any other charges to be included in the offers.”

- (3) SCANA Introductory Variable and SCANA Introductory Variable (Senior Discounts) are for new customers only and effective for the first bill. After the first bill, the rate reverts to SCANA Variable and SCANA Variable (Senior Discounts), respectively.
- (4) SCANA senior discounts are available to all senior 65 years of age and older, regardless of income.
- (5) Exit fee for Fixed Rate Plans is \$150/\$200/\$250/\$300 (depending on term) for customers leaving SCANA Energy prior to completion of fixed term or up to \$150/\$200/\$250/\$300 (depending on term) for customers

selecting a new fixed term with SCANA Energy.

(6) Carbon-Neutral Rate is used to purchase carbon offsets that support the development and sustainability of projects to reduce carbon emissions.

(7) These rates are for existing customers only.

The Base Charge from AGLC can be represented by the following formula: **\$28.77 + (\$6.17 x DDDC), for July 5th**. Prices billed to a consumer on a variable rate plan shall not exceed the published price in effect at the beginning of a consumer's billing cycle (meter reading period). The prices billed to a consumer on a fixed rate plan shall not exceed the published price that is in effect at the time the consumer contracted with the marketer.
