

BACKGROUND

Advanced Technology Group. LLC. (“ATG”) has been a licensed CLEC in the state of Georgia providing services to business enterprise customers since it was granted approval by the Commission in August 2019. The company had one (1) owner who held one hundred (100) percent equity in the limited liability company. Ms. Robin Hall (“Seller”, “Transferor”). On or about October 11, 2025, Ms. Hall sold one hundred (100) percent equity ownership to Mr. Edwin B. Pollock, III (“Buyer”, “Transferee”) (collectively with “Seller and Buyer”), extent required are informing the Commission of this change and also provide the following information,

- (1) This transaction was related to *equity only* while all other specifications and related to the Company and Customers have remained and will continue to remain the same; meaning (with the equity only purchase) there was no, nor will there be:
 - a. Transfer of customer base;
 - b. No disruption in service provided to any customer;

- c. No change to any Terms, Conditions and other contractual parameters between the Company and each/any of its customers remain the same and intact;
- d. No change to the Company's principal place of business, phone numbers, customer service support number, hours of operation, service offerings;
- e. No change to any Company staff members and no change to any internal processes and controls;
- f. No change to the Company FEIN number on file with the Georgia Secretary of State and no change to the Georgia Secretary of State control number; and,
- g. The Company will remain in full compliance with the Commission by adhering to all rules, terms and filing obligations as set forth with the grant of Commission approval for ATG CLEC license dated August 2019

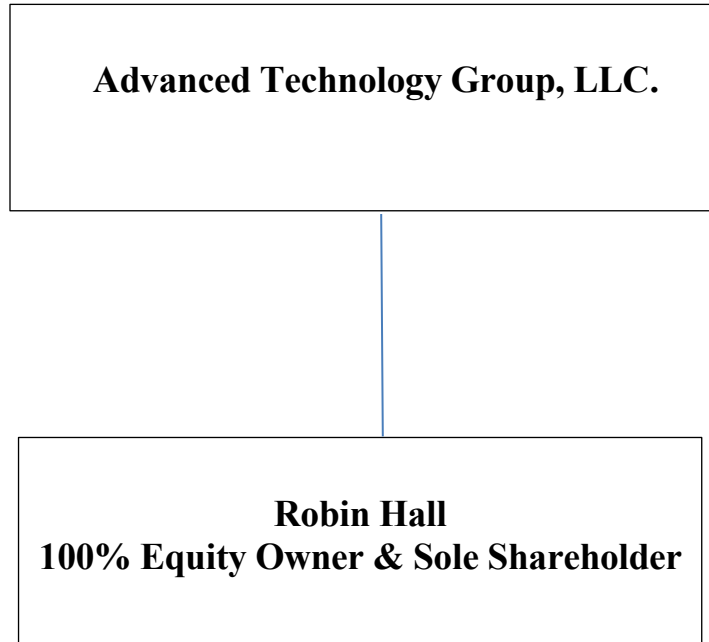

Post Transaction Organizational Chart

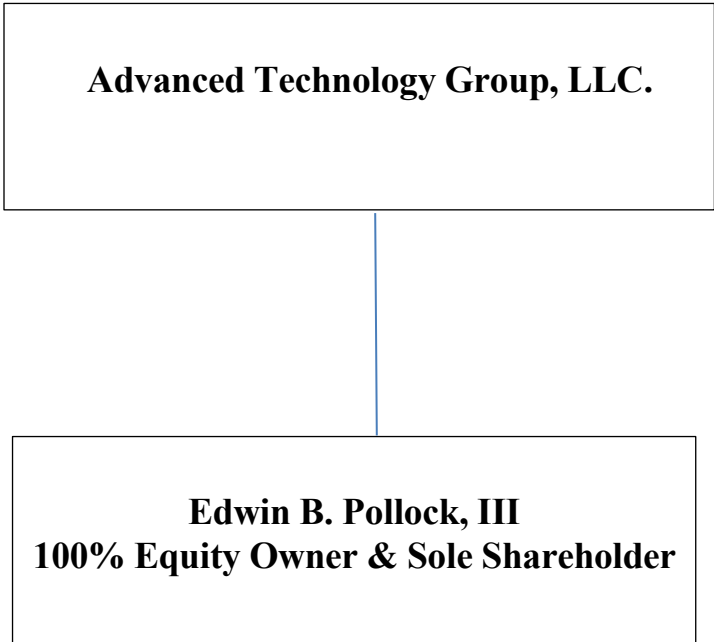
