Re: Request for Approval of the Name Change of AT&T Broadband Phone of Georgia, LLC to Comcast Phone of Georgia, LLC, d/b/a Comcast Digital Phone and Amended Tariff

Dear Mr. McAlister:

AT&T Broadband Phone of Georgia, LLC ("AT&T Broadband Phone of Georgia"), by its attorneys, hereby respectfully requests the approval of the Georgia Public Service Commission (the "Commission") to the extent necessary to effectuate the change of its name to Comcast Phone of Georgia, LLC, d/b/a Comcast Digital Phone.<sup>1</sup> AT&T Broadband Phone of Georgia currently is authorized by the Commission to provide competitive local exchange service to customers within the State of Georgia pursuant to Certificate No. L-002. The name change described herein is expected to be implemented on February 14, 2003.

This name change is related to the merger of AT&T Broadband Corp., including its telephony operations, with Comcast Corporation, which was the subject of the Notification filed with the Commission on March 6, 2002. By letter dated December 5, 2002, AT&T Broadband Phone of Georgia and Comcast Business Communications, Inc. notified the Commission of the consummation of the merger transaction and the related name change of

certain of the holding companies. This filing relates to the name change of the entity providing telecommunications service within the State of Georgia. AT&T Broadband Phone of Georgia is a wholly owned subsidiary of Comcast Phone, LLC (formerly known as AT&T Broadband Phone, LLC), which in turn is a wholly owned subsidiary of Comcast Cable Communications Holdings, Inc. (formerly known as AT&T Broadband Corp.). Comcast Corporation (formerly known as AT&T Comcast Corporation) is the ultimate parent of the foregoing entities. The name change will not result in a change in the carrier providing intrastate telecommunications services to customers in Georgia, or in the telecommunications services, rates, terms and conditions that those customers currently enjoy. There also will be no change in the current contacts for Commission and customer inquiries. Accordingly, the name change described herein will have adverse impact upon the current customers of AT&T Broadband Phone of Georgia.

To avoid any customer confusion or inconvenience, AT&T Broadband Phone of Georgia will provide written notification of the name change described herein to all current customers of AT&T Broadband Phone of Georgia by means of a bill notification or insert. At a minimum, the appropriate notification will be included with each customer bill not less than thirty (30) days prior to the proposed name change. The text of the notification to be provided to the current customers of AT&T Broadband Phone of Georgia is attached hereto as *Exhibit B*.


The existing tariff for local exchange services provided by AT&T Broadband Phone of Georgia has been revised to reflect the name change described herein. The tariff submitted herewith bears an effective date of February 14, 2003, which is the date on which AT&T Broadband Phone of Georgia expects to initiate telecommunications service under the new name. It is respectfully requested that the existing tariff of AT&T Broadband Phone of Georgia be cancelled on the effective date of the tariff filed herewith. A copy of the revised tariff is attached hereto as *Exhibit C*.

The proposed name change will serve the public interest by eliminating any confusion among customers as to the identity of their service provider. Specifically, several state commissions and customers of AT&T Broadband Phone of Georgia currently are directing service-related complaints and inquiries to the wrong carrier. AT&T Corp. will continue to use the AT&T brand name in connection with its remaining activities and therefore consented to Comcast Corporation's use of the name for only a limited period following the merger. By expeditiously effecting the name change, Comcast Corporation will avoid any such confusion. AT&T Broadband Phone of Georgia therefore respectfully requests that the Commission expeditiously approve, to the extent necessary, the change of its name to Comcast Phone of Georgia, LLC as described herein.
