AL-CALL, INC.'S PETITION TO AMEND
CERTIFICATES OF AUTHORITY

COMES NOW Al-Call, Inc. ("Al-Call") and hereby files this Petition to Amend Certificates of Authority requesting the Georgia Public Service Commission (the "Commission") to amend its Certificates of Authority to provide local exchange telecommunications services (No. L-0164), to resell interexchange telecommunications services (No. R-535), and to provide facilities-based intrastate interexchange telecommunications services (No. X-1037) to evidence Al-Call's adoption of the trade name "ATC".

Specifically, Al-Call requests that the Commission re-issue each Certificate of Authority previously granted to Al-Call to change the name thereon from "Al-Call, Inc." to "Al-Call, Inc. d/b/a ATC".

In furtherance of its request, Al-Call hereby notifies the Commission that it has complied with the requirements of O.C.G.A. § 10-1-490 to effect the registration of the business name of "ATC" both in the county where Al-Call is domiciled (i.e., Bacon County) and in each county in which Al-Call has significant operations (i.e., Pierce, Appling, Ware, Coffee, Jeff Davis and Glynn counties). Copies of the name registration filings made by Al-Call in the various counties are attached hereto at Exhibit "A".

WHEREFORE, Al-Call, Inc. respectfully requests that the Commission amend its Certificates of Authority to provide local exchange telecommunications services (No. L-0164), to resell interexchange telecommunications services (No. R-535), and to provide facilities-based intrastate interexchange telecommunications services (No. A-1037) to change the name on each Certificate of Authority from "Al-Call, Inc." to "Al-Call, Inc. d/b/a ATC".
